Silver Spring Dance Conservatory (SSDC) is a 501(c)3 not-for-profit dance school that has been serving western Lancaster County and its surrounding communities for more than 25 years.

We are so excited to announce the start of a new tradition in 2024, a holiday themed ballet entitled "Journey to the Land of the Sweets: A Nutcracker Tale," created, choreographed, and produced by Katie Reiter. Katie is a former New York-based professional ballet dancer who now lives here in Lancaster with her family and teaches ballet and pointe at SSDC.

This opportunity is open to all local ballet students ages 7-18. Dancers who train at other dance schools and studios are welcome to participate. Performances will have professional sets, backdrops, lighting and costumes, and are scheduled for December 20-22nd the Hempfield High School Performing Arts Center. Additionally, we will include at least one sensory friendly performance for young children and patrons who may require a gentler and more relaxed viewing experience.

In an effort to broaden access to live ballet performance in our community and break down common barriers to attendance including cost, time, location, and accessibility, all performances of "Journey to the Land of the Sweets: A Nutcracker Tale" will be free to attend with a "pay what you can" donation option at the door. Participation for dancers will be free of charge as well.

This is where you come in! While we have grant opportunities in the works, we will be relying heavily on donations and contributions from our community to fund this project. We will be using a tiered donor system and all donors will be listed in our programs.
